In Memoriam.

Shipmates, it is my sad and solemn duty to inform you of the loss of our shipmate Grover Anthony Kiick.

Grover A. Kiick was born in North Bergen, NJ on 12 Oct 1914. He served on-board and Qualified in Submarines on USS Pipefish (SS-388) during WWII and attained the rank of MM1 (SS). He also served on-board USS R-2 (SS-79). Grover was also a "Plankowner" for the USSVI-Pocono Base when the base started on Feb 15, 2000 and was an active member until his health declined. Grover was married to Kathy Kiick for 23 years. Grover made a decision to end his dialysis treatments and "Volunteered" for Eternal Patrol on 9 Feb 2010 at the age of 95.

Services for Grover were held on 12 Feb 2010 at Bolock Funeral Home in Cresco, PA. Pocono Base Founder, Chaplain and Life Member Robert Vaughan and his wife, Ruth, conducted the funeral services. Rich Holmes, Tom Shields, Frank McDevitt, Bob Smith, Bill Klose and Michael Smith served as Honor Guard during both the Subvet Ceremony and the Funeral Ceremony.

Grover was interred at the Prospect Cemetery in East Stroudsburg, PA.
