A moment of silence was held after the reading of the lost boats.

The Chief of the Boat led the members present in reciting the Pledge of Allegiance.

Members present introduced themselves and the boats they qualified on.

We were joined by the wives of some of the members.

The Secretary verified that a quorum was present.

As this is our first meeting since nominations for the Base Officers opened in February, the Secretary cast the vote that the following members who declared their intentions, be elected for the next two year term for 2020 - 2022:

Bob Smith as Base Commander, though he is still looking for someone to take over. Bob Obrecht as Base Vice-Commander Michael D. Smith as Base Secretary Alan Dempsey as Base Treasurer.

Meeting Minutes: The March to June Minutes have been posted. These were minimal minutes, more as placeholders. The February minutes have also been posted to the website.

Treasurers Report: The treasurer report an actual ending balance of \$x as of 30 June 2020. Only 5 checks have been written since February.

Committees:

Budget & Donations: No report.

Eagle Scouts: Eagle Scout Courts of Honor as stated in New Business.

Kap(ss) 4 Kid(ss): Bob Obrecht stated that the program has been on hold since the pandemic started.

Fundraising: Raffle has been cancelled for this year, due to the cancelation of the West End Fair, Victorian Day's. If anyone has any ideas for fundraising, please come forward with the idea.

Mike Smith read from the Submarine Operations of WWII on the loss of the USS Robalo. Robalo was lost due to an explosion of her after battery. The only survivors were captured and never heard from again, based on a note that was received by Mrs. Mendoza. The sub sank a couple miles off the coast of Palawan.

Old Business: Bob talked about the West End Fair. This event has been cancelled this year, but we have not received our check back from them. It also has not been cashed in.

Since there is no fair and this is our largest event in which we sell the raffle tickets, it has been decided to cancel the raffle this year. The fair takes in enough to clear all of the expenses with the raffle.

Bob recommends the only donations are to go to the Wilson-Fischer Post this year.

The bus trip that we were trying to plan has been cancelled for this year as well. We will look into planning a trip for wither next spring or fall. Alan said that Martz would refund our deposit, but it could take about 30 days.

Bob said that the group had already approved in having business cards made, but we have not pursued this yet. We are also looking into having another replacement for our membership cards and get away from the metal versions.

This is an outdoor ceremony and will follow all current COVID-19 guidelines. Due to the short notice, this will also be mailed. Bob talked about the Christmas Dinner from last year at Woody's. While it was ok, there was room for improvement. Bob and Sheila were on the way back from dropping flags off at the post Sheila said they noticed that Robert Christians is under new management and spoke to the new owners about possible having our Christmas Dinner there this year. The place has been renamed as Murph's Hideaway. Since some of the members have asked over the years about having it during the day time, Sheila asked the owners if we could do so. The only date currently available was Sunday December 20th at 1PM. Sheila said they were willing to work with us. Other members have said that the food is good there.
