
United States Submarine Veterans, Inc. Pocono Base – Meeting Minutes Wednesday, 17 September 2025

Meeting called to order at 18:59 by Base Commander Bob Smith at the American Legion Wilson-Fischer Post in Pocono Pines, PA. The Purpose of the Organization was read. The Acting Chief of the Boat led the men in reciting the Pledge of Allegiance.

We were joined by the wives of a couple of our members.

The Secretary verified that a quorum was present.

Prior to the rest of the meeting, a special election was held to nominate, vote and install a new Base Treasurer. Alan Dempsey resigned his position as Base Treasurer and Chief of the Boat.

Tom Crosby nominated Scott Jackson for the position of Base Treasurer. Bob Obrecht made the second nomination for Scott Jackson. Scott Jackson accepted the nomination to become the new Base Treasurer. As there were no other nominations for the position, Base Secretary, Michael D Smith cast the vote for Scott Jackson to be the new Treasurer.

Scott Jackson accepted the position and was sworn in as the Base Treasurer by the Base Secretary. This position is for the remainder of the 2024 - 2026 cycle and will re-open in January 2026.

Meeting Minutes: The August Minutes were posted to the website but were subject to questioning. The Base Secretary was not at the August meeting, and the minutes were taken by Scott Jackson.

Parades: Carbon County Veterans Day Parade, Lansford, PA and Monroe County parade in Stroudsburg, PA. Covered in new business.

Mike Smith read from Submarine Operations of WWII on the loss of the USS Cisco. Cisco was lost due to anti-submarine activity and bombing attacks from Japanese Aircraft. Cisco was lost with all hands.

Old Business: Bob Smith reported that we only made \$2170 at the West End Fair this year. Enough to cover our raffle expenses. We received \$1000 from our time at the racetrack back in June. A total of \$98 was received from raffle ticket sales at Tractor Supply last week. We have upcoming dates for more table sales on the 24th of September and on the 4th of October at Shop Rite in Brodheadsville, PA.

The Celtic Classic in Bethlehem again, is coming up shortly. Our group is a go for Sunday, the 28th of September. Again, we will be manning the beer tent, pouring drinks from the taps, collecting money and any tips we receive during our time frame belong to the base. Tom said he sent the information to Bob Smith for dissemination to those members going to the Celtic Classic. We are encouraged to wear our vests and even bring the Base Banner. Their short notice requests resulted in fewer groups showing up due to prior commitments. Tony doesn't expect it to be any better next year. Tony also stated that they had finally got electricity in the afternoon for our tent.

Alan Dempsey stated that the base has still not received the new permit from the state for the trailer. Alan provided the new treasurer with a copy of the letter that was sent back on August 16th. We have not received a reply as of tonight's meeting

New Business:

Scott Jackson will need to be added to the Authorized Signature list at PNC Bank. We will need a letter from our base using our letterhead and a signed copy of our meeting minutes

stating that Mr Jackson is the new Base Treasurer. Information about the account is in the Treasurer package.

We received an invitation to the Monroe County Veterans Day Parade months ago. There are two parades. One is on the 2nd of November for the Stroudsburg parade and the 8th for the Carbon County Parade. Will line up at the Stroudsburg High School by 12:30 PM and step off at 1PM. The parade will end at Dansbury Park in East Stroudsburg, PA. The Carbon County parade will step-off at 2PM and will be in Lehighton this year. Lineups and maps will be finalized by the October Meeting. Scott Gerber stated that we have not received an invitation for the Carbon County Parade as of tonight's meeting.

The budget committee will meet 45 minutes before the November Meeting to work on the donations for the year. If there are any charitable organizations that would be worthwhile, please make your recommendation.

There was a Eagle Scout Court of Honor request received by mail for a Jake Merritt. His court of honor will be held at St Paul's Lutheran Church, 158 Fish Hill Road in Tannersville, PA on Saturday the 20th of September at 2PM. Scott Jackson said he would do this presentation.

Scott Gerber talked about the car show that was postponed back in June at the Polk Township Fire Company due to poor weather conditions. Scott stated that the gentleman is looking at having a couple of shows. The first is on the 21st of September at the Blue Ridge Winery, the next is on the 18th of October at the Polk Township Fire Company. Scott suggested attending to build a good rapport with the organizer. Bob Smith stated that we do try to do these types of events to help educate the public about our mission and what we did as submariners.

Alan Demspey stated that donations to our base are reported at the end of the year financial report to national. These are separate entries that need to be reported.

Dave said he talked with Jeff Owens, former commander of our base before the split to form the Scranton Base.
